

Official Rules & Regulations
Grandstand Social- Champions Bucks

1. Open to eligible guests attending at a Grandstand Social event (each, an “Event”), held in Champions Bar & Patio at Woodbine Racetrack, 555 Rexdale Blvd, Toronto, Ontario (the “Venue”). Contest runs every Friday, commencing on Friday, July 28th, 2017 and ending on Friday, September 1st, 2017, from 3:00 pm ET until 11:00 pm ET on each such Friday night (each, a “Contest Period”). Woodbine Entertainment Group (“WEG”) is the sponsor of this Contest.
2. No purchase is necessary to enter the Contest. By participating in this Contest, each contestant agrees to be legally bound by these Official Rules & Regulations (the “Rules”).
3. To enter the Contest, guests must do the following:
 - (a) Each guest will receive 5 “Champions Bucks” upon entry at an Event.
 - (b) Guests may wager their “Champions Bucks” with other guests playing the various games featured at each Event to earn more “Champions Bucks”.
 - (c) Guests must fill out their information on the back of their “Champions Bucks” and place their completed “Champions Bucks” into the designated ballot box at the Venue no later than 11:00 pm on the date of the applicable Contest Period.
4. One (1) week after each Contest Period there will be three (3) Weekly Prize winners selected. Weekly Winners will be selected by random draw by WEG from amongst all eligible entries received at the applicable Event. The Grand Prize draw which will be drawn from all eligible entries received from all Events following the last Contest Period. All winners will be contacted via telephone within one (1) week of each Contest Period.
