For the Breeder's Stakes, \$1,000 is due two weeks before the race; \$5,000 at time of final entry. Horses not originally nominated may supplement at time of final entry for a non-refundable fee of \$12,500 which includes the entry fee. All monies received from the original nomination (February 1, 2011) will be divided equally between the gross purses for the Queen's Plate, Prince of Wales and Breeders' Stakes. In each race the purse to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Final entries to be made through the entry box at the closing time then in effect for overnight events.

# CONDITIONS

The Rules of Racing of the Ontario Racing Commission in effect at the time the race is run shall govern this race and any/all entries to the race will be received only with the understanding and on the agreement of the owner that the said Rules of Racing govern, and that the following additional conditions apply:

1. (a) Woodbine Entertainment Group, its Directors, officers, employees and agents shall not under any circumstances be liable or responsible for loss, injury or damage to horses or personal property of any horse owners or trainers or their agents, servants and employees whether or not such loss or damage results from or is caused by the negligence of Woodbine Entertainment Group, its Directors, officers employees and/or agents. The trainer, owner and their respective servants, agents and employees hereby agree that all horses and property as aforesaid on the premises of Woodbine Entertainment Group shall be deemed, for the purposes of this subparagraph, to be within the sole and singular care, custody and control of the owner, trainer and their respective agents, servants and employees and further that Woodbine Entertainment Group shall not be responsible for the safety and well being of the horses and property of the aforesaid while on its premises.
- (b) The owners, trainers and their respective agents and employees agree, in consideration of Woodbine Entertainment Group allowing the presence on its premises of the property and horses of the owner, trainer and respective agents and employees, to indemnify Woodbine Entertainment Group and its Directors, officers, employees and agents against any loss, damage, injury or costs, including legal costs, incurred, sustained or suffered by any of them, caused by:
  - (i) any of the said horses as a consequence of any negligence of the owner or any person in the employ of the owner or under the owner's control or charge including any trainer or any person in the employ of or under the control or charge of any such trainer or by any person, firm or corporation with whom the owner has contracted, or employee thereof, with respect to the care, custody and control of the said horses; or
  - (ii) the owner or by any person in the employ of the owner or under the owner's control or charge, including any trainer or any person in the employ of or under the control or charge of any such trainer, or by any person, firm or corporation, or employee thereof, with whom the owner has contracted with respect to the care, custody and control of horses or personal property on the premises of Woodbine Entertainment Group; or
  - (iii) personal property belonging to the owner or in the owner's possession or control occurring on the Woodbine, or Mohawk Tracks or occurring while the horses are being transferred to or from one or other of the said race tracks; and in particular to indemnify Woodbine Entertainment Group and its Directors, officers, employees and agents, and each of them, from any and all claims in respect of injury or death of the owners horses occurring from any cause whatsoever, including, without limiting the generality of the foregoing, injury or death of the owners horses as a result of the negligence of Woodbine Entertainment Group, its Directors, officers, employees and/or agents.
2. Every person subscribing to a Sweepstakes of entering a horse to be run under the said Rules accepts the Stewards on any question relating to a race or racing. At the absolute discretion of Woodbine Entertainment Group or the Racing Association conducting the race (each of which is hereinafter called the Racing Association), or of the Stewards and without notice the entries of any person or the transfer of any entry may at any time be refused and/or cancelled without either notice or reason being given and without liability except for the return of any subscriptions paid on an entry or entries refused and/or cancelled.
3. The Racing Association reserves the right to cancel the race without liability therefore upon repayment of all subscriptions fees, if any, paid on such cancelled race.
4. The conditions of any race, including the distance of the race or the track, whether polytrack, dirt or turf, may be changed by the association, with no refunds of nominations or entry fees.
5. Woodbine Entertainment Group does not guarantee stabling accommodation to all horse nominated for Sweepstakes and in its discretion may refuse to allot stalls without liability.
6. It is expressly understood and agreed that Woodbine Entertainment Group, in its absolute discretion, may limit the number of starters in the race, or may run the race in two or more divisions. If the field is limited, high weights (including scale or weights) shall have preference, and in the event of equal weights, those horses having the highest lifetime earnings at the time of final entry shall have preference. In the event that the application of the condition described in this paragraph results in the exclusion of any horse only the final entry fee previously paid will be refunded.
